A: After several minutes of searching the web I found this article. The binary file is a signed file, so it cannot be opened in some environments. Then I converted it to a zip archive, unzipped it in Notepad++ and there it was. appealable decision has been rendered, a notice of appeal is necessary to invoke the appellate court's jurisdiction. See TEX. R. APP. P. 25.1(a). The filing of a notice of appeal that shows the jurisdiction of the court is essential to a court of appeals' jurisdiction. State v. Riewe, 13 S.W.3d 408, 411 (Tex. App.—Austin 2000, no pet.). Here, Appellant filed her notice of appeal on July 30, 2014. The trial court's order granting the City's plea to the jurisdiction was signed on November 26. 2013. Therefore, on the date the notice of appeal was filed, the order granting the City's plea to the jurisdiction was not appealable. See Riewe, 13 S.W.3d at 410 (appellate court determined that order granting appellee's plea to the jurisdiction was nonappealable because the order was not 4 signed until after appellant filed notice of appeal).1 Appellant's notice of appeal did not invoke this court's jurisdiction. We conclude that we lack jurisdiction over this appeal, and we dismiss the appeal. See Riewe, 13 S.W.3d at 411. APPEAL DISMISSED.
